	paid his/her subscription for more than three months is eligible to vote in the election.
(b)	For the posts of Zonal Secretary of each zone, only the Members of respective Zones,
	who are eligible in 32(a) above, will be eligible to vote and contest in the elections.
(c)	Only those members who have served AIR/Doordarshan for at least two years or more on
	the date of notification of the elections and are still in service in AIR/Doordarshan and
	have at least two years of service left on the date of filling of nominations, will be eligible
	to contest in the election, subject to satisfying all other conditions.
(d)	Members, who are retiring/have retired from service on or before 31st March of the
535 350	Election Year, are not eligible to participate in the elections.
(e)	A member will be allowed to file the nomination for one post of Office Bearer only.
(f)	Those contesting the elections, have to deposit Rs. 500/- (rupees five hundred only) as
	Security Deposit, in cash or by bank draft (payable at Delhi), along with nomination form.
	The Security Deposit shall be forfeited for the candidate, for whom the total votes polled
	are less than ten percent (10%) of the total votes cast & found valid.
(g)	The Proposer & Seconder filing the nomination form for elections are eligible to sign only
.07	for one candidate, for one post. The Nomination proposed and/or seconded for two or
	more contestant by same Proposer and/or Seconder, will become invalid.
