Subject: Non-Functional up-gradation for Officers of Organized Group 'A' Services in PB-3 and PB-4

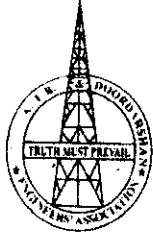
Dear Madam.

As you are aware, consequent upon the acceptance of the recommendation of the 6th pay commission DOPT has issued two orders vide O.M. No. AB 14017/64 /2008-Estt. (RR) dated 24-04-2009 and O.M. No. AB 14017/64 /2008-Estt. (RR) dated 21-05-2009 (copy enclosed for ready reference) for grant of non-functional up gradation for officers of Organized Group 'A' services in PB-3 and PB-4. According to these orders "whenever an Indian Administrative Services Officer of the state of joint cadre is posted at the centre to a particular grade carry a specific grade pay in pay Band-3 or Pay Band-4, the officers belonging to batches of Organized Group A Services that are senior by two years or more and have not so far been promoted to that particular grade would be granted the same grade on non functional basis for the date of posting of the Indian Administrative Services Officer in that particular grade at the centre".

Further, as indicated under point (iv) of the above order Establishment Division of DOPT will issue orders from time to time in consultation with the Establishment Officer intimating the Batch of the officer belonging to the Indian Administrative Services who have been posted at the Centre in the various grades of PB-3 and PB-4 as well as the date of posting of the first officer belonging to the Batch.

Further as mentioned under point 6. Of the ANNEX I to the above order grant of higher pay scale on the non functional basis would be from the date of posting of the First Officer belonging to the particular batch of IAS Officer at the Centre. In case of any delay in the issue of orders, financial benefit under these orders will be given from the due date.

DOPT vide their O.M. No AB 14017/64 /2008-Estt. (RR) dated 21st May 2009 has indicated in the Annexure the details of batch of the Officers belonging to the Indian Administrative Services who have been posted at the centre in various grade of PB-3 and PB-4 w.e.f 01.01.2006 as well as the date of posting of the first Officer belonging to the Batch. Batches of organized Group 'A' Services to be considered for non functional up gradation is also indicated in the column 4 of the same Annexure. All Ministries/Department

are directed to grant of higher scale to the Officers belonging to the batches of Organized Group A services that are senior by two years or more.

In light of above, more than 200 Officers of IBES of AIR and Doordarshan are to be granted higher pay scales on no-functional basis w.e.f 01-01-2006. The grant of higher scales on non-functional basis shall be granted by a screening committee chaired by Secretary, Ministry of I&B.

Therefore, in compliance of above order, a batch-wise proposal along with all the requisite documents viz. CR dossiers, etc. is to be forwarded to the Secretary I&B at the earliest. The action in this regard may please be taken by the concerned section of DG: AIR as it has been done in case of MACP.
