

3. The appointment of the above mentioned officers will be subject to the final outcome of the Writ Petition No.CW-13007-11/2006 filed by Shri K. K. Maurya and Others in the High Court of Delhi and the persons who are granted the NFPS shall not be entitled to any equity on account of the grant of non-functional pay scale.
