Subject: Minutes of ADEA CWC Meeting held on 20/02/2023

The meeting was chaired by President, ADEA. On the outset, Gen secretary intimated that a proposal is received from ADEA members in which it has been stated, "a SLP has been filed in the Hon'ble Supreme Court of India against the impugned final order and Judgement passed by the Hon'ble High Court of Delhi in W.P. (C) 8056/2015 titled as Rajiv Sinha & Ors Vs. Ministry of Personal, Public Grievance and Pension & Ors dated 01.11.2022 regarding Pay Parity of IB(E) S cadre. To defend the case in the Hon'ble Supreme Court of India, It is requested that a sum of Rs. 5.00 Lakhs may be allocated towards the instant SLP from the legal fund collected from ADEA members." The status and merit of the case was apprised to the CWC by Sh P S Srivastav, IB(E)S.

The proposal was discussed and deliberated at length by the participating members. Considering that the outcome of the instant SLP may be beneficial to all the officers of IB(E)S and the case has merit, it was unanimously decided that Rs. 5.00 Lakhs, shall be provided for the instant SLP.

Further, it was also emphasized by members that possibility of inclusion of other IB(E)S officers may explored so as to cover all the batches in this case in order to get the benefit of outcome of this SLP, in case it is won by the members fighting the case.

The meeting ended with thanks to the chair as well as members, who spared time to attend the meeting.
